# 2018 Teal on the Hill

#### Inaugural Event to lobby for the Spina Bifida Community in the US

On May 9<sup>th</sup>, 100 people from 29 states gathered in Washington D.C. for the Spina Bifida Association's first annual Teal on the Hill event. This unique experience was an opportunity for people with Spina Bifida and their families to visit Capitol Hill and meet with their respective Senators and Members of Congress.

Participants were able to tell their life stories and discussed some specific issues that were outlined in an advocacy training that took place the previous night. Advocates encouraged legislators to sign onto the Spina Bifida Caucus, increase funding for the CDC's National Spina Bifida Program by a million dollars, and to oppose a bill that would put wheelchair parts and catheters under competitive bidding.

Participants were divided up by state and/or region. There was a total of 78 meetings throughout the day that resulted in great conversation and a few new members of the Spina Bifida Caucus. Samantha Greenberg and Frank DiEva represented SBADV and had the opportunity to meet with the office of Congressman Brendan Boyle, who represents Northeast Philadelphia.

# Alert about a New Financial Planning Program for persons with Disabilities

#### PA ABLE Savings Program for Disability-Related Expenses


A PA ABLE account gives individuals with qualified disabilities (Eligible Individuals), and their families and friends, a tax-free way to save for disability-related expenses, while maintaining government benefits. Federal and state law authorized the creation of PA ABLE accounts.


#### **Contribution Information:**

- Contribute up to \$15,000 each year. This federal limit may be adjusted each year based on
  inflation and may be exceeded by account owners who are employed. See the <u>FAQs</u> for
  additional information on the website below.
- Families and friends can contribute to an account. The account limit applies to total contributions and is not per contributor.
- Account maximum of \$511,758. Once limit is reached, no additional contributions can be made. Interest can still be earned.
- **Deduct contributions on PA income taxes.** Contributions to a PA ABLE account may be deducted from state taxable income. **Only contributions to a PA ABLE account qualify for the PA state income tax deduction.**
- Roll over a 529 college account. Roll over money from a 529 college savings account to a PA ABLE account, up to the ABLE annual contribution limit (\$15,000 in 2018).

### Financial Assistance offered by SBADV

Please submit your requests to our chapter.

SBADV provides financial assistance in the following categories. Requests for reimbursement for medical expenses must include documentation that the expense is not covered by insurance or that the request submitted is for the individual's co-pay amount. There is a yearly maximum for each fund, but the total yearly amount available to each individual with Spina Bifida is capped at \$1,500.00. The Association's fiscal year is January to December.

Requests for reimbursement must be received by March 15 of the year following the date of the incurred expense.

**Direct Patient Aid** provides up to \$1,500.00 for medical bills related to Spina Bifida but not covered by the Incontinence or Equipment Funds.

**Equipment Fund** provides up to \$1,500.00 per year for the purchase of wheelchairs, crutches, braces, and other adaptive devices.

**Incontinence Fund** provides up to \$1,000.00 a year for uncovered incontinence supplies.

**Post-Secondary Education** provides up to \$1,500.00 for expenses related to attending college, trade school or other specialized training to gain employment.

**Campership Fund** provides financial aid for adults and children to attend camp or other group activities during the summer for socialization. Maximums are determined yearly by the Board based on the amount budgeted for the fund and the number of individuals requesting funds.

**National Event Fund** provides assistance of up to \$500.00 to individuals who qualify for participation in a national-level sports, academic or talent competition.

**Driver's Education Fund** provides one-time funding of up to \$500.00 for behind-the-wheel driver's education training.

**Conference Assistance** provides funding to cover conference registration and up to \$550.00 (or an amount determined by the Board of Directors) for expenses related to attendance at SBA's Regional Conferences. Reimbursement amounts for attendance at SBA-sponsored Educations Days will vary due to location and are determined by the Board.
